Meeting held Thursday 25<sup>th</sup> February

Simon Finn was present. He is the parliamentary Secretary to the Premier on Vet affairs matter

Go card expenses referred to Minister and Qld Govt

If we use our TPI warrants we are being charged about 1/3 more

An example was that if I use the Go Card from Caboolture return It would cost \$10.80 whereas the paper ticket cost \$15.80

PSA Blood tests referred to minister

PSA Blood tests one per 12 months unless clinical need

If you have more than one year you have to pay for the extras

The minister stated that if there is a clinical need then we will pay

Robotic Prostate Surgery  
Three ways normal, keyhole and robotic  
Recovery from robotic is much cleaner and quicker  
Prostate surgery is covered under DVA but not robotic due to cost. Can be paid if it is clinical need  
Doctors have to prove clinical need not just two lines

#### **9.10 ANZAC Day Dawn Service Committee**

Governor has agreed to be Patron as long as she is Governor  
All parties approached agreed to come on board  
Acting CEO Peter Rule is coming on board as a member  
We are conducting a peaceful assembly  
We do not have to answer to the Qld RSL  
Only answerable to BCC  
The ANZAC Day Dawn Service Combined Committee has the complete support from the State Government and BCC  
The Qld RSL only lease the offices  
The Qld RSL do not lease the Shrine or Crypt  
The Letter of Agreement between Qld RSL and BCC over the rest of the Square null and void since 2006  
Demands from Qld RSL are not required to be met  
These demands are out of order  
ANZAC Square is not a work place it is a Peaceful Assembly  
Only lights that will be turned off are the standard lights in the park itself  
Brown Velvet Cinema submitted quote all signing all dancing about \$20 000  
Screens in place from the Thursday to the Sunday with power point presentation showing WWI and Gallipoli will be shown  
ADCC has agreed to print the Order of Service and cover costs,  
Now in the hands of the printer that does the children's service  
We have a copy of the barricade and road closure plan from BCC,  
A copy of the program is in the hands of the printer, who is preparing a draft for our approval,  
Army Band, Nasho Pipes and Drums, St John's, QAS, SES and BBC Choir have all agreed to participate,  
Copy of the anti-discrimination actions on hand no directions given but a couple of options outlined,  
ADCC has agreed to allow the ADDSCC to become a sub-committee,  
The ADDSCC has agreed to this  
By the ADDSCC becoming a sub- committee, then ADCC responsible for all costs,

ADCC have a copy of the quotes for screens and sound and will decide,  
Governor, Premier, Leader of Opposition and British Consulates have responded and will attend  
We have a copy of the protocol forms from both Government and State which have to be filled out  
and returned when everything is finalized.

I have been told verbally that the Lord Mayor will be present

I believe that all these people that are attending are there to critically assess our running of the  
service

Most of the things put in place at the moment are to ensure that this year goes off without a hitch
